However, HUD/FHA and USDA rural appraisals require a more in-depth examination of the subject property. In addition to explaining the differences between conventional and HUD/FHA and USDA rural appraisals, this seminar, through the use of on-site photos, will give you the ability and confidence to identify the physical components that are found during an appraisal inspection. You will acquire the knowledge necessary to identify component defects that might affect the subject's value or be a health and/or safety issue.

It is intended to raise the bar and transform the appraisal inspection process by equipping the appraiser with the necessary knowledge and instilling a professional confidence that will result in a more precise and reliable appraisal.
