All attendees will receive the current USPAP document and student manual.

Course Objectives

- Present and explain the new revisions to USPAP adopted in 2011 and effective from January 1, 2012 through December 31, 2014.
- Address those areas of USPAP that are most commonly misunderstood or questioned.
- Present “real world” scenarios that challenge participants to interpret and apply USPAP to situations they encounter in their daily practice.

This course provides seven hours of appraisal continuing education credit. There is no accompanying exam for this course.

Course Location and Lodging Information
